FHA Connection System Maintenance

On Saturday, August 2, 2014, the FHA Connection Origination Case Processing application will go offline four hours earlier than usual. The application will go offline at 4:00 PM Eastern Time so that FHA can deploy system changes related to policies announced in Mortgagee Letter 2014-07, HECM Non-Borrowing Spouse, Mortgagee Letter 2014-12, HECM Program: New Principal Limit Factors and Mortgagee Letter 2014-08, Guidance on Nonprofits Assisting Government Entities in Providing Secondary Financing in Conjunction with FHA-Insured Mortgages. Refer to the respective Mortgagee Letters for specific data entry requirements.

Mortgagees will be unable to request new case numbers until the application is back online on Monday, August 4th, 2014, at 8:00 AM Eastern Time. Mortgagees are reminded that FHA reserves the right to review case number assignments and revoke any case number assigned that violates FHA regulations and guidance.
