What's New

Final Extension of Annual Recertification Filing Deadline for Certain Title I and Title II Lenders and Mortgagees

In recent weeks, FHA has worked diligently to address issues affecting lenders' use of the LEAP 3.0 system. To date, the vast majority of the problems impacting lender recertification functions have been addressed. While some isolated issues specific to particular lenders are still being investigated, lenders should be actively attempting to complete their recertifications in LEAP.

In order to accommodate those lenders that have been prevented from completing their recertifications in LEAP, FHA has extended the recertification filing deadline for Title I and Title II lenders and mortgagees with the following fiscal year end dates:

- December 31, 2013
- January 31, 2014
- February 28, 2014
- March 31, 2014

The deadline to submit complete recertification packages for this group of lenders and mortgagees, including financial information and annual renewal fees, has been extended until **July 31, 2014**.
