Correction to FHA INFO #15-60: Multi-Topic Announcement: Updates to Single Family Housing Policy Handbook // REMINDER: SF Handbook Effective Date // Training Webinar: LEAP Post-Approval and Changes

Today, the Federal Housing Administration (FHA) is issuing a correction to the Newly Published Updates to *Single Family Housing Policy Handbook* section of the multi-subject FHA INFO #15-60 that was issued on August 13, 2015.

In the release, FHA reported that HUD Handbook 4145 REV-2, *Architectural Processing and Inspections for Home Mortgage Insurance*, will be superseded **in whole** on September 14, 2015.

The actual language, however, should have read: HUD Handbook 4145 REV-2, *Architectural Processing and Inspections for Home Mortgage Insurance*, will be superseded **in part** on September 14, 2015.
