\$7.7 Million in Housing Funds Awarded

The South Dakota Housing Development Authority (SDHDA) recently announced the approval of \$7.7 million in housing development and rehabilitation funding for the state which includes \$2.6 million in Housing Tax Credits (HTC), \$3.4 million in HUD's [HOME Investment Partnerships Program](#) funding and \$1.7 million in Housing Opportunity Funds.



Westwood Apartments in Sioux Falls

A total of 22 projects will be funded which will provide 255 new multifamily housing units, 16 new single family housing units, 50 rehabilitated multifamily housing units and 11 rehabilitated single family homes, as well as 45 individuals and families with down payment assistance and 150 individuals and families with homelessness prevention assistance.

The Westwood Apartments in Sioux Falls is one of six housing projects awarded tax credits and HOME funds. The project, which will cost nearly \$8 million, received \$535,000 in tax credits, \$685,000 in HOME funds (\$4,815,000 HTC Equity), and a \$350,000 loan from the City of Sioux Falls. Grandview LLC will construct the seven buildings which will provide 56 affordable units in southwestern Sioux Falls. The apartments will provide homes for tenants with incomes that range from at or below 30 to 60 percent of the area median income. Construction is planned to begin this fall. Regional Administrator Rick Garcia met with the Sioux Falls Diversity Council on April 23, 2014 to discuss opportunities within the diverse communities of the city. He spoke about how the [HUD Section 3 Program](#) could bring opportunities to individuals and businesses in the diverse communities in Sioux Falls. The program requires that low income persons and businesses that employ those persons receive priority consideration for job training, employment, and contracting opportunities that are created from specific HUD funds.

The City of Sioux Falls held a press conference to announce their recent [Fair Housing Awareness Program](#). Mr. Garcia stated "ensuring that housing is available to

all without discrimination has benefits for the city as a whole. When people have housing choices and a stable housing environment, they are more prepared to meet challenges and children do better in school." (see Fair Housing Awareness on page 4)



Blueprint for Access

In an effort to provide an opportunity for all qualified first-time homebuyers to purchase a home, FHA announced its "Blueprint for Access" which expands access to credit for underserved borrowers. HUD published a notice in the Federal Register on May 15, 2014 for the four-year Homeowners Armed with Knowledge (HAWK) pilot program to further incorporate housing counseling into the home buying process for borrowers.



The housing counseling provided intends to improve homebuyer's budgeting skills and housing decisions while providing an average savings of an estimated \$325 per year or almost \$9,800 over the life of the loan. The pilot program also includes enhancing FHA's quality assurance efforts, intending to provide greater clarity and transparency to FHA-approved lenders to encourage lending to qualified borrowers across the credit spectrum.

Energy Efficient Mortgages

FHA's **Energy Efficient Mortgage (EEM)** program helps homeowners save money on utility bills by allowing them to finance the cost of adding energy efficiency features to a new or existing home as part of their home purchase or refinance. EEMs recognize that reduced utility expenses can permit a homeowner to pay a higher mortgage to cover the cost of the energy improvements on top of the approved mortgage.

EEMs can be used to make energy efficient improvements in one to four units in existing and new homes. The improvements can be included in a borrower's mortgage only if their total cost is less than the total dollar value of the energy that will be saved during their useful life. Other eligibility requirements may be found in the [Homeowner's Guide](#).

FHA Updates



On February 28, 2014, FHA issued [Mortgagee Letter \(ML\) 2014-05](#), authorizing new templates for applications for FHA multi-family mortgage insurance. The intent is to streamline the application process, standardize the underwriter's narrative, and incorporate recent underwriting policy changes. The new templates for applications are required for applications filed 120 or more days after the issuance of the ML.

On April 25, 2014, FHA issued [Mortgagee Letter 2014-07](#), effective on or after August 4, 2014, which makes significant prospective revisions to the status of the non-borrowing spouse in the event of the death of a Home Equity Conversion Mortgage mortgagor.

Section 184 Loan Program Fee Increase

HUD published a [Final Rule](#) in the March 5, 2014 Federal Register that increased the fee to guarantee a Section 184 Indian Housing Loan Program to 1.5 percent of the principal obligation from the current rate of 1 percent, effective April 4, 2014.

\$1.6 Million for Housing Authorities

HUD recently awarded \$1.6 million in [Capital Fund Program](#) grants to [Public Housing Authorities](#) in South Dakota. The grants allow housing authorities to build, repair, renovate and modernize the public housing units in their communities. The funding is used for large-scale improvements such as new roofs, plumbing, and electrical systems.

Homeless Programs Receive Funding

HUD recently awarded over \$1.2 million to members of the [South Dakota Housing for the Homeless Consortium](#). The Continuum of Care grants provide permanent and transitional housing to homeless persons, as well job training, health care, mental health counseling, substance abuse treatment, and child care.

HUD Provides Over \$10 Million for Housing in South Dakota

The State of South Dakota along with the cities of Rapid City and Sioux Falls will receive over \$10 million in Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME), and Emergency Shelter Grant (ESG) funds from HUD this year.

[CDBG](#) funds can be used for many kinds of community development activities. [HOME](#) funds allow state and local governments to fund grants, provide direct loans, loan guarantees and other forms of credit enhancements to expand and preserve affordable housing.

[ESG](#) funds provide grants to states, cities, and counties for essential services related to emergency shelter, rehabilitation and conversion of buildings to be used as emergency shelters, operation of emergency shelters, and homelessness prevention services.

Secondhand smoke travels from unit to unit as the smoke can seep through outlets, heating, and duct work. The only effective way to stop the spread of secondhand smoke is by adopting a smoke-free policy. Cigarette use often leads to health problems, increased fire risk and property damage, leading to expensive renovations. Since issuing Housing Notice 2010-21, more than 420 public housing authorities have adopted some form of smoke-free policy.

Sioux Falls Housing Market

HUD's Office of Policy Development and Research [Housing Market Profile](#) report for Sioux Falls shows during the 12 months ending January 2014, nearly 4,100 homes sold, an increase of 12 percent from the previous year, with the average home selling for \$175,800. There were less homes on the market - 1,600 in January 2014, a decrease of 4 percent from a year ago. Homes in foreclosure were 2.5 percent in January 2014, down from 2.9 percent a year ago.

The apartment vacancy rate averaged 4.3 percent in January 2014, an increase from 3.6 percent last year. The vacancy rate decreased from 13.3 percent in 2010 due to a decline in construction activity. The average apartment rent was \$650 in January 2104, an increase of less than 1 percent from last year and the first rent increase since 2009. Multifamily construction attained record levels with approximately 1,050 units in 2013, more than double the average of 410 new units from 2010 to 2012.
